SPCALA ADOPTED OUT 3,250 ANIMALS, REUNITED 556 PETS WITH THEIR FAMILIES, FOSTERED 625 ANIMALS IN TEMPORARY HOMES, AND TRANSFERRED 69 ANIMALS TO OTHER ORGANIZATIONS.

CALIFORNIA'S FIRST PETSMART CHARITIES EVERYDAY ADOPTION CENTER (EAC) IN PICO RIVERA OPERATED BY SPCALA, WHICH OPENED IN NOVEMBER 2014, CONTINUES TO FIND FOREVER HOMES FOR OUR CLIENT ANIMALS.
